I, _____ RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY, AND PARENTAL CONSENT AGREEMENT FOR 2011 RCP TIBURON MILE OPEN WATER SWIM CLINIC.

In consideration of participating in the 2011 RCP TIBURON MILE SWIM CLINIC fundraising event ("Tiburon Mile") taking place in 2011, at the Tiburon Peninsula Club, I represent that I understand the nature of the Swim Clinic and all of its activities, and that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in the Swim Clinic event. I acknowledge that if I and/or my minor child believe that any of the Swim Clinic activities or related conditions are unsafe, I and/or my minor child will immediately discontinue participation in the Swim Clinic event and any or all of its related activities.

I fully understand that this event and its related activities may involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in these activities, the conditions in which the activities takes place, or the negligence of any or all of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for any losses, costs, injuries, harm, and/or damages that I and/or my minor child incur as a result of my and/or my minor child's participation in the Tiburon Mile event and any or all its related activities.

I hereby release, discharge, and covenant not to sue the RCP Tiburon Mile, RCP Events, Inc., the Tiburon Peninsula Club, including their respective administrators, directors, officers, employees, agents, representatives, volunteers, any other event participants, any event sponsors or advertisers, and, if applicable, any other owners or lessors of premises on which any of the Swim Clinic activities take place (each considered one of the "Releasees" herein), from all liability, claims, demands, losses, damages, or costs on my account caused or alleged to be caused in whole or in part by the negligence of any of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any liability, demand, loss, damage, or cost which any may incur as the result of such claim.

I further understand that I or my health insurer (and not any of the Releasees or their insurers) will be responsible to pay for or otherwise cover any or all of the expenses in connection with any injury that I and/or my minor child may suffer in connection with the Swim Clinic event and any or all of its related activities. I have read and understand this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY, and PARENTAL CONSENT AGREEMENT. I understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, the balance notwithstanding shall continue in full force and effect.
